Request from NANAY, Inc. for additional funding assistance in the approximate amount of \$200,000 for building renovation through the CRA's Economic Development Assistance and Incentive Fund - Commercial Grant Program (Attachment)

Note: The CRAAC discussed this subject during its meeting on January 5, 2009 and considered the following motion as advisement to the CRA Board:

To recommend that 1) the CRA Board approve funding to NANAY, Inc. in an amount up to \$245,000 comprised as follows: (a) \$200,000 for the building renovation project, (b) up to an additional \$20,000 or 10% as a contingency to be funded at the discretion of the CRA Executive Director, and (c) up to an additional \$25,000 from the CRA subject to a required funding match by NANAY, Inc.; and 2) the City and/or the CRA address the need for improvements to the municipal parking lot located behind the NANAY building.
