

Museum is a fundamental part of North Miami, poll finds

The Museum of Contemporary Art, North Miami (MOCA) is a fundamental part of the North Miami community, according to a survey conducted by Emerson College Polling.

The survey of North Miami residents reveals 94% find the arts to be important to their community's quality of life.

The strong partnership with North Miami makes MOCA more than a building, it is an anchor within the community, said Chana Budgazad Sheldon, MOCA's executive director. Families are utilizing North Miami resources and facilities, with about half of those being children who have attended or been involved in programs offered the museum's educational, cultural, children's art camps or after school programs.

"While MOCA's reputation for presenting groundbreaking contemporary exhibitions is recognized nationally and internationally, the arts have always had deep roots in the community. We are thrilled that our hard work and services

nesses, the polling reported. Some 79% of residents are likely to visit MOCA in the next six months. This includes 88% of those who have already visited and plan to return in the next six months.

MOCA will continue to work with the city and participate in multiple city officials' events such as Back to School Block Party and Winter Wonderland, Ms. Sheldon said, and host programs in the community including MOCA Art and Library for seniors and art classes for seniors.

MOCA's North Miami presents contemporary art and its historical influences through exhibitions, educational programs and collections. Inaugurated in 1981, the institution moved to its current location in the Center of Contemporary Art. The establishment of the permanent collection coincided with the institution's move into its current building at 770 NE 125th St., which was designed by Charles Gwathmey of GSX.

"What is so nice," Ms. Sheldon added, "is that our efforts can be seen in our survey."





Introduction

In adherence to the statutes outlined in Florida Statutes, Chapter 163 Part III, commonly known as the Community Redevelopment Act of 1969, as amended, the North Miami Community Redevelopment Agency (NMCRA) continues its dedicated efforts towards the revitalization of designated “slum” and/or “blighted” areas within the City of North Miami.

a budget generated by the increase in property tax revenue within the designated area. Once a CRA is established, a percentage of the increase in real property taxes is allocated to the CRA. This tax increment serves to fund and finance the redevelopment projects outlined in the Community Redevelopment Plan.



Established with the principal mission of preserving or expanding the community redevelopment area's tax base, as stipulated in Section 163.355 (5) of the Act, the CRA is committed to stimulating the rehabilitation and redevelopment of designated areas primarily through private enterprises. The Tax Increment Financing (TIF) mechanism, unique to community redevelopment agencies, serves as a stable source of funds to initiate and catalyze redevelopment within the community redevelopment area during the period of increasing tax base in designated slum and blighted areas.

Community Redevelopment Agencies are widely recognized as an effective governmental tool for redevelopment in Florida. They operate on

partnerships with stakeholders, we have continued to adapt and evolve to meet the evolving needs of our community.







Interlocal Cooperation Agreement



The North Miami Community Redevelopment Agency (NMCRA) is excited to announce a groundbreaking agreement that has injected approximately \$4 million into economic development initiatives in North Miami for FY 24. This strategic partnership aims to revitalize the community, stimulate local businesses, and improve the overall quality of life for North Miami residents. Also this QR code links to a message saying the video has been removed.

On October 6, 2023, Commissioner Marleine Bastien hosted a press conference to discuss a resolution sponsored by the commission providing an amendment to the original Interlocal Cooperation Agreement between Miami-Dade County, the City of North Miami, and the NMCRA. The new agreement

removes a \$1 million dollar cap and provides the NMCRA with an additional \$4 million to invest in projects that bring economic development to the area in FY 2024 alone, which is projected to increase every year moving forward. The resolution was passed unanimously on Oct. 3rd by the Board of County Commissioners.

Thanks to the collaboration of Mayor Daniella Levine Cava's administration, the City of North Miami, and the NMCRA, the revised agreement provides an unprecedented amount of funding to be invested in projects included in the NMCRA's Redevelopment Plan including Affordable Housing, the North Miami Mobility Hub, Northwest 7th Avenue Redevelopment, and North Miami Downtown Revitalization.

Unprecedented Funding:

Thanks to the combined efforts of Mayor Daniella Levine Cava's administration, the City of North Miami, and the NMCRA, an extraordinary amount of funding has been secured. This financial commitment will serve as a catalyst for the successful implementation of various projects that are integral to North Miami's transformation.

Affordable Housing:

Affordable housing remains a top priority in North Miami. The revised agreement ensures substantial funding dedicated to affordable housing projects, creating housing opportunities for residents and contributing to the city's inclusivity and sustainability.

Northwest 7th Avenue Redevelopment:

The revitalization of Northwest 7th Avenue is a cornerstone of North Miami's development strategy. The funding injection will accelerate this project, rejuvenate this vital corridor and attract businesses and investments.








NoMi Express Trolley Service


