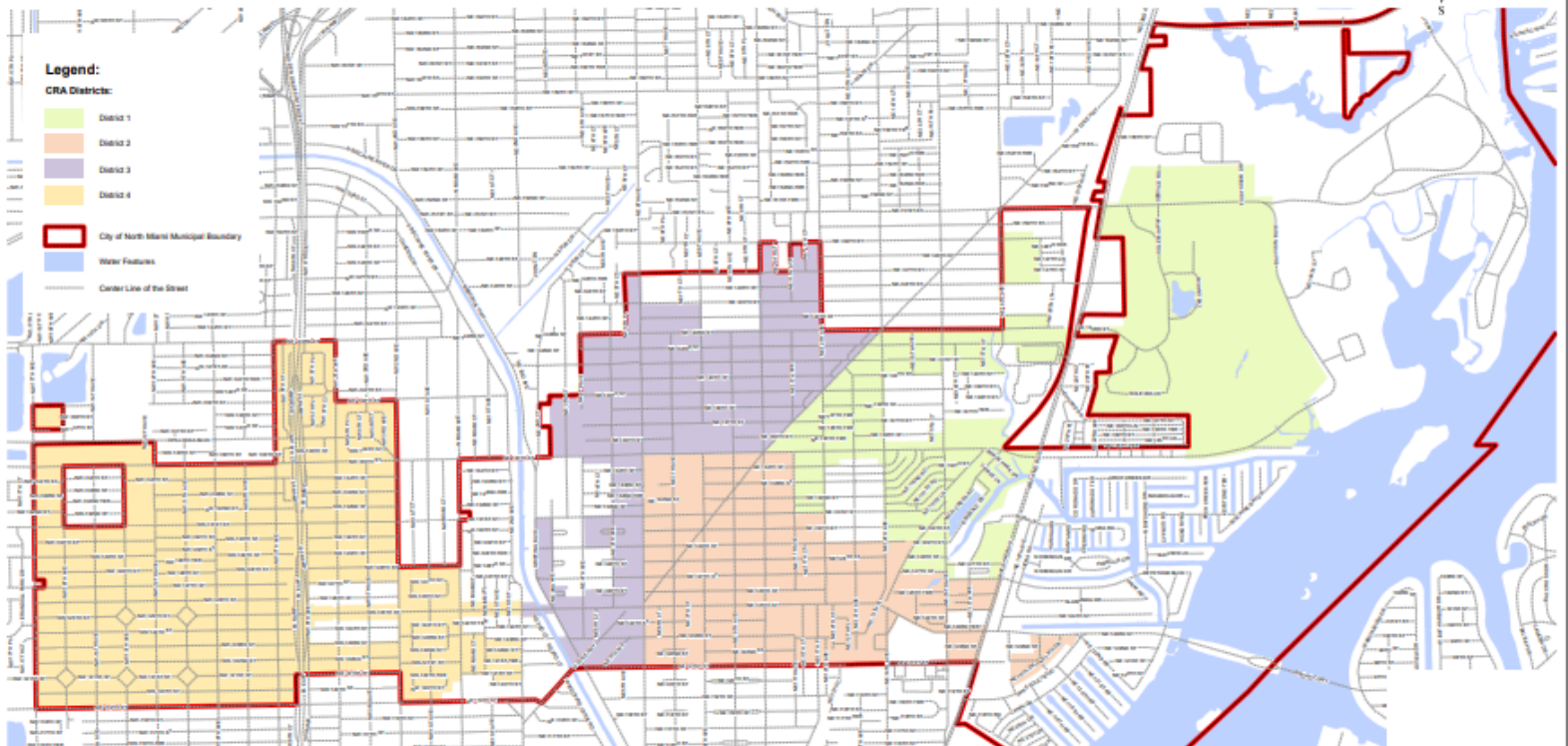
City of North Miami CRA Boundary Map
